KCB Emergency Directive (2020-03) -- June 11, 2020

Today City Administrator/Emergency Management Director Christopher Moonis, in consultation with the City Commission, is issuing the following Emergency Directive (2020-03) to make a more specific COVID-19 emergency order than Monroe County for Key Colony Beach. This is intended for the benefit of our Residents, Businesses and Guests. This directive supports Governor Ron DeSantis' Phase 2 initiative for reopening of Florida (Executive Order 20-139, which moves the State of Florida into Phase 2 of the "Safe. Smart. Step-by-Step Plan for Florida's Recovery.")

This KCB Emergency Directive orders all persons entering a City-owned facility or business establishment to wear masks entering and while doing business in those facilities. In restaurants, masks may only be removed when sitting at a table or bar.

This KCB Executive Order also requires all owners/staff to wear facemasks during time in their respective businesses.

The reasoning behind the order is:

1. Limited medical facilities in the Keys;
 - a. Two emergent care hospitals and one temporary emergent care hospital,
 - b. Limited isolation beds in the Keys,
 - c. Our medical is sized for our Resident population of around 76,000;
2. We are 34% short term rentals, a very high percentage of our homes;
3. Our population is an average age of 63, bordering on the most at-risk population;
4. We do not know when this pandemic will peak and be well-controlled;
5. Miami Dade, Broward and Palm Beach Counties are still in phase one. Their beaches are closed along with other restrictions that would invite their residents to come to the Keys for relief;
6. We have invited many vacation renters to the first full week of the summer rental season in our close to 500 rental homes in KCB. Most will come from South Florida.
7. Stronger restrictions we had in place have kept us healthier than most tourist heavy counties
8. We are all for opening our economy, but as we learn more about COVID 19 we are seeing more studies that support wearing masks in public as the top way to stop the spread of the virus.
9. We are asking each of you to take it upon yourselves to wear a mask in all public establishments and requiring them of customers and staff.

As to inconsistencies between Monroe County Directives or Orders, the City's directive above shall control in the City of Key Colony Beach.

Violation of these orders are punishable with penalties or fines. Code enforcement will continue to educate businesses in violation before reporting to KCB Police.
